MESSAGE FROM THE CHAIRMAN


This annual report marks the completion of the 12th year of RAHMA Islamic Relief's successive work on the ground. The report covers the period from January 2021 to June 2022. The board of trustees decided to publish annual reports aligning with the financial reporting period. Thus, instead of following the calendar year, from now onwards, we will publish annual reports as per our financial year (July- June).

Since 2009, 1,046,851 people have benefited through our programs and projects in Healthcare, Education, Water Sanitation and Hygiene, Livelihood, Humanitarian support and seasonal activities. During the reporting period, we served 188,421 persons in 25 districts of four provinces of the country, including Azad Kashmir, through our six thematic programs.

We responded promptly to the needs of marginalized and vulnerable communities timely during the COVID-19 pandemic. Emergency food campaigns started for marginalized people such as daily wage workers, the poorest, women & orphan-headed households. More than 2000 marginalized families assisted with dry ration packages. The provided services, particularly during the third and fourth outbreaks, were widely recognized. The government of Pakistan awarded an appreciation certificate. We also signed MOU with the Economic Affairs Division, Government of Pakistan, during the early months of 2021.

I am very grateful to the RIRF-Norway Board of Trustees for their continuous support. I am equally thankful to Charity for Life Denmark, Imdad Relief Foundation and all other institutional and corporate donors, including those who contributed individually. I am also proud of all my staff as they possess a great team spirit, devotion and professionalism. Many thanks to the community volunteers for their support and cooperation with our field teams. I am also thankful to the officials in concerned government departments who cooperated with us in times of need.

RAHMA Islamic Relief (RIR) was registered on August 31, 2009 as a non-profit, non-governmental entity under the Trust Act, 1882, Government of Pakistan. (Registration No. 1629). The organization is a signatory of MOU with Economic Affairs Division (EAD), Government of Pakistan. RIR is also awarded by certification from Pakistan Centre for Philanthropy (PCP) because of its quality standards in the areas of internal governance, financial management and programme delivery.

The organization is also member of different global forums as Stop TB Partnership and Union of NGOs of the Islamic World (UNIW). In addition, its healthcare programme in Punjab is registered from the Punjab Healthcare Commission, Government of Punjab. (Registration No. R-32277). RIR is a national-level NGO in Pakistan, inspired by the Islamic charity principles and is working for uplifting of lives of the vulnerable and marginalized people regardless of their gender, caste, color, religion or political ideologies.

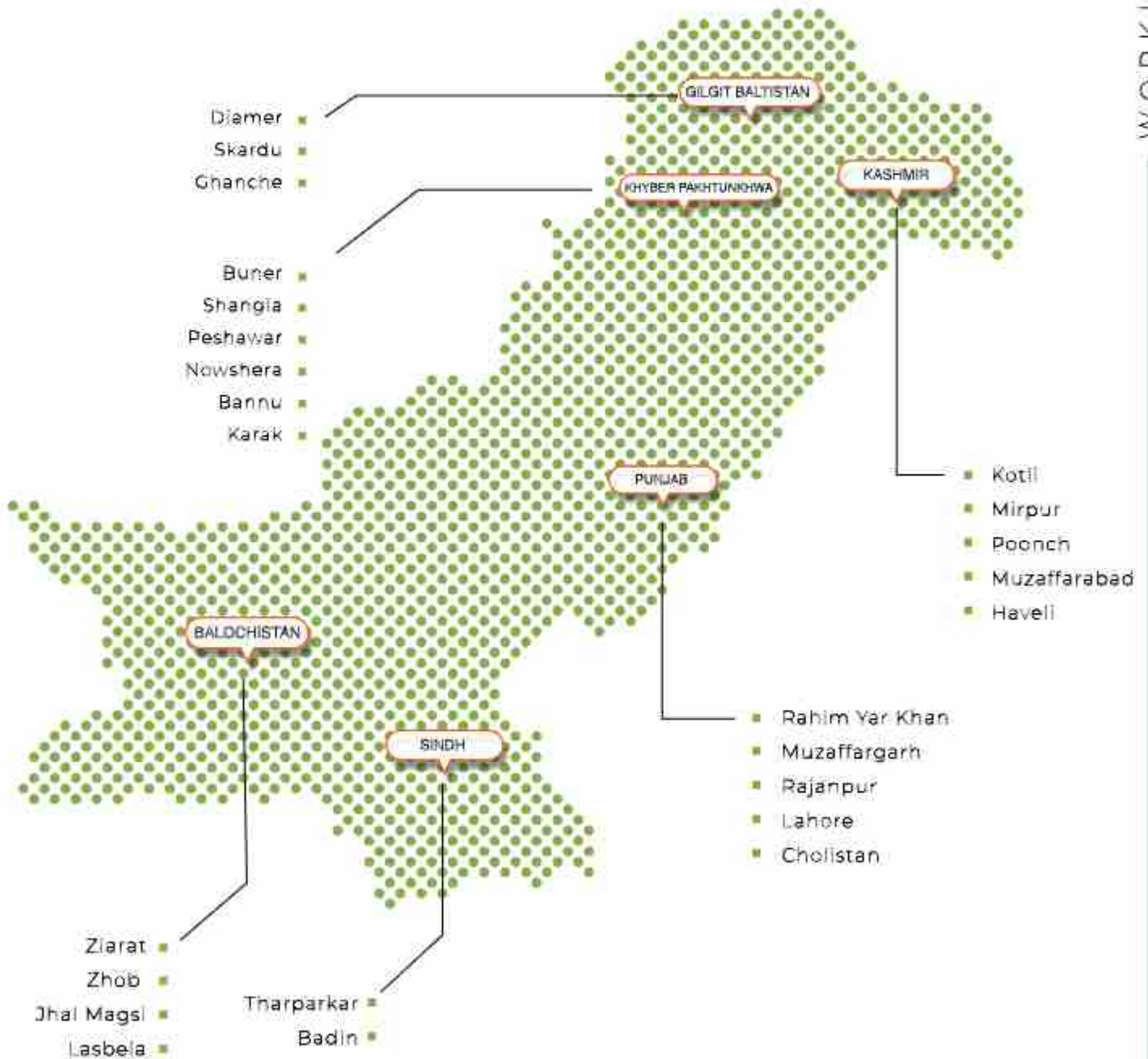

HEALTH & NUTRITION

Quality Healthcare for All

One of the major challenge confronted in Pakistan is access to healthcare (prevention and cure). The immense burden of a non-communicable disease alone is responsible for 50.5% of all deaths in the country. Women and children suffer more due to the scarcity of quality healthcare services especially in the remote rural areas. Thousands of women lose their lives from preventable complications during the pregnancy & delivery process, and newborn care is not available in various parts of the country. We are striving to increase access to the quality and timely healthcare services of the geographically remote and economically challenged and marginalized communities, through providing various services.

There are 2 ongoing hospitals in Khuiratta AJK and Janpur in Rahimyar khan in which thousands of patients are being treated annually. In the year 2021-2022 over 74,529 were provided with quality healthcare in these centers. These healthcare centers were built for the most deprived strata of society that are providing following services to these neglected communities:

- Outpatient Consultation & Diagnostic Services
- Maternal, Newborn & Child Health Services
- Ambulance Services
- Addressing Malnutrition
- Health coverage to marginalized, women, elderly and People with Disabilities
- Rehabilitation & Construction of Health Infrastructure
- Training of Traditional Birth Attendants (TBAs) Community Mobilization & Organization Health
- Awareness & Education

- Health Screening & Medical Camps
- Laboratory tests
- Radiology (Digital X-ray & Ultrasonography)
- Pharmacy
- Labor Room Services
- Eastern Medicine Center

These services are provided through two regional Healthcare Centers named "RAHMA Hospitals".

1. RAHMA Hospital Janpur, Rahim Yar Khan &
2. RAHMA Hospital Khairatta, Kotli, AJK

These hospitals are applauded and considered a blessing of Allah by the local inhabitants of these respective areas as they can access these centers easily without the fear of their financial miseries and problems to acquire timely and quality healthcare services.

Other Highlights

- Polio campaigns were initiated in both RAHMA Hospitals in Khuiratta and Janpur in order to support the government's drive of eradicating polio from Pakistan.
- A Free eye medical camp was arranged on 15 January 2022 at RAHMA Hospital Janpur Rahim Yar Khan with mutual understanding of "RAHMA Islamic Relief" and "Ahsas-e-Insaniyat welfare", in which a qualified team of surgeons performed 700 eye operations by following protocols regarding Cataract (white pearl) procedure.
- Training of Birth attendants was conducted at RAHMA Hospital Khuiratta Brooth Nar on 12-01-2022.
- Awareness Session on Covid 19 Preventive measures, diabetes, Uric acid, Blood Pressure and so forth.
- Eastern Medicine Clinic initiated its operations on 28-02-2022 in collaboration with Qarshi Foundation at RAHMA Hospital Khuiratta.
- Another Free medical camp was organized at khuiratta Manjwar Kandi.
- A free Medical Camp was arranged at RAHMA Hospital Janpur RYK in which doctor's consultation, medicine and random blood sugar tests were provided free of cost to the patients.
- RAHMA Hospital Khuiratta Brooth Naar set up an emergency camp during the famous cattle fair in Khuiratta, Kotli.
- Three days medical camp was arranged in Rahimyar Khan.

EDUCATION

A Basic Right of Every Child

Article 25-A of the Pakistani Constitution states that "The State shall provide free and compulsory education to all children of the age of five to sixteen years in such manner as may be determined by law" and "Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all" is also included in United Nation's Sustainable Development Goals 2015 but the education sector in Pakistan depicts a grim picture. Although, primary education coverage is increasing in Pakistan gradually; however, the issues of access to education require immediate attention and needs to be highlighted. Great progress has been achieved in providing access to quality learning opportunities for every child. Globally, more children than ever are in school and, in general, girls and boys attend in nearly equal numbers. Despite these achievements, progress, in many places, has been inequitable. And record numbers of children have had their education interrupted by conflict and emergencies.

Pakistan has the second-highest number of Out-Of-School Children (OOSC) at the primary school level in South Asia, over half of whom are girls. Government statistics indicate that an estimated 22.6 million children, aged 5-16, are out-of-school (44% of all children in this age group). A significant number of OOSC belongs to the poorest, marginalized and, socially excluded groups living in self-made tarpaulin huts in the slum areas of Pakistan. Approximately, there are around 15,000 children in Rawalpindi/Islamabad who belong to such group and, are not enrolled in the schools. RAHMA initiated the program of providing free education services to such children in the year 2012. Initially, we opened up a school within a slum area near Rawalpindi Railway station, in a small hut. Later on, it succeeded in constructing the very first school for such marginalized children. The building structure of the RAHMA Model School for the students of (playgroup to class v) was completed and inaugurated in the March of 2019. In addition to providing learning materials and management training for school systems, RAHMA worked to improve learning outcomes through teacher development programmes and advancement of robust early childhood development policies and learning systems. Moreover, another educational institution of similar nature was opened in Ashiqabad, GML, Tehsil Liaquatpur, Rahim Yar Khan prioritizing girls' education that plays a crucial role in the development and progress of a country and it was a widely felt need of the rural areas of Rahim Yar Khan.

2021 HIGHLIGHTS



- Educational Awareness Session with the parents was held at RAHMA Model School.
- RAHMA with collaboration of HASHOO Foundation organized medical camp for the children of RAHMA Schools.
- A sports event –“RAHMA SPORTS GALA 2021”was organized on 8-12-2021 at RAHMA Model School Ashiqabad GML southern Punjab, in which the students of the school participated in different games and it comprised of various healthy activities.
- December brings grief, anger and agony for the families those still struggling to come to terms with the deadly terror attack on a school in the north-western Pakistani city of Peshawar, in this backdrop, staff and students of RAHMA Model School Ashiqabad Rahimyar khan paid tribute to the victims of this incident and prayed for them.
- A trip of senior classes from RAHMA Model School Rawat was arranged for the Multi Zoo B- 17 and Science Museum of Pakistan Shakar Pariyan Islamabad. Students enjoyed a lot as many items presented in Museum are also a part of curriculum which found to be a great learning part for the students.
- RAHMA Islamic Relief distributed College uniform gifts to students of Government Girls Degree College Khairatta.



WATER, SANITATION & HYGIENE (WASH)

Go Green and Drink Clean

Pakistan has made significant progress in improving access to sanitation yet 25 million people still practice open defecation. Lack of access to proper sanitation facilities impacts negatively the health and wellbeing of children. 53,000 Pakistani children under five die annually from diarrhea due to poor water and sanitation. Children suffering from repeated episodes of diarrhea are likely to fall behind in school or drop out altogether. Furthermore, it can also cause stunting that currently affects almost 44 percent of children in Pakistan. Pakistan's vulnerability to disasters including earthquakes, floods and droughts, often leave hundreds of thousands of affected people in need of emergency water and sanitation support. Sustainable access to water, sanitation and hygiene in health centers and schools also remains a challenge. The effects of climate change and rapid urbanization also contribute to challenges of improving access to safe water and sanitation.

Safe drinking-water, sanitation and hygiene are crucial to human health and well-being. Safe WASH is not only a prerequisite to health, but contributes to livelihoods, school attendance and dignity and helps to create resilient communities living in healthy environments. An estimated 70 percent of households still drink bacterially contaminated water. Our goal is to provide pure and clean drinking water to those who are compelled to drink impure water and living in the remote areas far from available water sources. They travel and expense a lot to fetch water for their households use. For years RAHMA has been making pure and clean drinking water accessible to those who do not have access to it and thus are vulnerable to water-borne diseases.

Our work varies considerably according to each situation, from giving one-off practical help and advice to people on the move, to installing semi-permanent and permanent infrastructure to cater to the water and sanitation needs of hundreds of thousands of people. In all cases, we look to improve longer term futures for people, challenging the conditions and norms that have caused people to be disproportionately hit by crises. From Jan 2021 to Dec 2021, we installed 15 hand pumps in different village of Tharparker, Sindh. Another water bore with tank installed in a remote and hilly village located in Karor, Rawalpindi. In addition, 15 hand pumps were also installed in different villages of UC Giryancho, Islamkot in the Sindh province during the month of Ramadan in 2021. 6 water filtration plants were also installed in Khuiratta, Seri, Saldpur, Tattapani and Kotli, AJK. Moreover, 5 solar water wells were also installed in different villages 9 RO Plants were installed in different areas of Rahim Yar Khan.

The project included installation of complete solar systems at aforementioned locations with the help of our partners.

Humanitarian Relief Activities

Pakistan is confronted with multiple challenges at various fronts but extreme poverty, hunger and plummeting economy is one of the major challenge for Pakistan. The World Bank (WB) has estimated that poverty in Pakistan has increased from 4.4 per cent to 5.4 per cent in 2020, as over two million people have fallen below the poverty line. Pakistan's new poverty index reveals that 4 out of 10 Pakistanis live in multidimensional poverty. Moreover, The Covid-19 pandemic has worsened the situation of the already poor and neglected communities in Pakistan. The health care sector was extremely burdened by the huge influx of Covid-19 patients. Although the government made its endeavors to cope up with the challenging situation in the country yet these initiatives were not sufficient to cater the needs of every person in the country. Moreover, the government machinery does not has the resources and capability to address every issue and problem confronted by its citizens. In this background, RAHMA Islamic Relief came forward and executed many activities to mitigate the suffering of the most deprived and under privileged strata of society.

1. Provision of Silage during the drought in South Punjab

Cholistan regions is one of the most hot and dry regions of Pakistan where temperatures can reach up to 50 Celsius in the summer. Most of the rural communities are dependent upon herding cattle for milk, meat, livelihood and ultimately their survival. The climate of the desert area, with scanty and unpredictable rainfall as well as long periods of drought, makes water a limited resource. The region also has scarcity of water resources and the inhabitants of the region have to endure

the scorching summer heat and have to walk many miles on foot to get water for them and their animals. This year's brought another challenge for the residents of the region when the area was hit by a devastating drought due to recurrent spells of extreme heat waves. Hundreds of animals died due to the unavailability of water and silage due to the droughts. To address the issue of water shortages and to secure access of water to livestock, the people of Cholistan have created water ponds, called "tobas". However, due to their vulnerability to extreme weather conditions and infiltration, the ponds storage capacities are low. There are around 1500 water points (tobas) in the entire desert out of only 500 were in running condition. Most tobas are not constructed in proper places because their present localities have not been identified on scientific basis to receive maximum rainwater. In order to ease the suffering of these people, RAHMA Islamic Relief Pakistan responded promptly and distributed 28000 kg of silage to 2650 beneficiaries who were most effected people from Moaza Channa Peer of the Cholistan region. People of the area were extremely grateful for the aid and considered it a blessing of Allah in these difficult times.

Haveli, Forward Kahuta is one of the most remote and backward area of Azad Kashmir with extremely low infrastructure development. Due to its location near the border with Indian occupied Kashmir, it had been attacked and devastated time to time by the heavy artillery bombardment by the Indian Armed Forces. Furthermore, the earth quake of 2005 completely destroyed the whole villages in the area. The overall literacy rate is very low and people are mostly poor and depend upon the agriculture and daily wage jobs to earn their livelihood. The area also has a very poor health care system with substandard hospitals and clinics.

RAHMA collaborated with Qarshi Foundation and stepped up their efforts to provide immediate assistance and Covid-19 prevention 2000 flu kits to the vulnerable people of Azad Kashmir.

The recent withdrawal of US forces from Afghanistan and subsequent takeover of the country by the Taliban has created chaos and a humanitarian crisis in the country. The reports coming out from Afghanistan are very disturbing where people are selling their belongings and possessions. Thousands of poor families have already sold their flocks and fled, seeking shelter and assistance in packed temporary camps near major cities in the harsh winters of Afghanistan. In this backdrop, RAHMA Islamic Relief Pakistan provided assistance to RAHMA Islamic Relief Fund Norway, Charity for Life Denmark, Punjab Cash and Carry, and Qarshi Foundation, to initiate an emergency humanitarian assistance and food campaign for most affected and vulnerable families of Afghanistan. Resultantly, RIRP started its relief operations in 2021-2022 and provided food packages and non-food items (Blankets, winter clothing, stoves etc.) to more than 1200 families in Nangarhar, Kabul, Jalalabad, Samarkhail, Wardak, Taitamoor, Farm Adda, and Arzanqemat in Afghanistan.

In addition, RAHMA had provided food packages, including blankets, to the deserving groups of people in Afghanistan during the last couple of months. While doing these distributions, we observed that people could manage curry in one way or the other. The bread (which they take from clay ovens generally) is the prime and constant need. Thus, we

installed two clay oven with the help of RAHMA Islamic Relief Fund Norway and Imdad Relief Foundation to provide ready-made NAAN in Kabul and Jalalabad for the deserving people. These Naan centers are providing free naans to more than 200 families for lunch and dinner every day.

Moreover, the recent earthquake on June 22, 2022 in Afghanistan further exacerbated the problem where 1150 people lost their lives and hundreds of houses were turned to rubbles. In this backdrop, RAHMA Islamic relief with the help of Imdad Relief Foundation decided to initiate an emergency humanitarian assistance and food campaign for most affected and vulnerable families of Afghanistan. Resultantly, provided 69 food packages to the families in Pakteeka, Afghanistan.

Ramdan Food Distribution

Sharing Happiness

Ramadan is the holy month, in which the Muslims perform fasting and getting closer to Allah SWT by following the teachings of Islam. The month has many significances but serving humanity apart from all differences is considered highly valuable. Every Ramadan, We provides food parcels with help of Muslims brothers living in Norway, Denmark and other parts of the world. The food baskets contain essential items such as oil, flour, sugar, Rice, basan, daal, white chana, Jam e Sheeren and dates. These baskets/parcels are distributed to deserving families in different urban and rural locations in Pakistan. The food parcels allow them to be better prepared for the month of Ramadan, easing their worries about how to access food with which to start and end their fast. The Ramadan project has been implemented in 11 districts including two districts of AJK with the help of our partners that are RAHMA Islamic Relief Fund Norway, Charity for Life Denmark and some generous individuals.

QURBANI

Pakistan is a country facing multiple challenges, and COVID19 has affected the progress on poverty reduction and social development indicators. The country's daily wage workers, slum dwellers, lower-middle and blue-collar employee class have suffered the most. These years, Eid was different for all of us due to COVID19 pandemic, which broke the socio-economic fabric and severely impacted the less privileged ultra-poor members of the community. Every year on the occasion of Eid ul Azha, we distribute meat among the poor communities that do not have the financial capacity to acquire meat in the whole year due to abject poverty. This activity provides the opportunity to the beneficiaries to enjoy the happy moments of the auspicious occasion of Eid-ul-Adha, especially to the vulnerable women and children providing them meat in a substantial quantity. RAHMA Islamic Relief Pakistan reached out to the most vulnerable and marginalized communities of rural areas of Punjab, Sindh and Azad Kashmir. Overall 103 cows, 8 oxen, 49 Goats and 45 Lambs were slaughtered and distributed 13,934 KG of meat among the 20,920 beneficiaries on the day of Eid. RAHMA implemented this seasonal project - Qurbani programme with the help of our generous partners RAHMA Islamic Relief Fund Norway, Charity for Life Denmark and with contribution of individual philanthropists. Vulnerable and marginalized communities were targeted through the project, who received nutritional-rich meat packs (2.5-5 KG each).

Olive Tree Grafting Project:

Pakistan is confronted by multifaceted problems on multiple levels but one of the major challenge that masses are faced with is abject poverty. Poverty is prevalent all across the country but the areas located far from the cities are more affected by poverty because of illiteracy, lack of infrastructure and economic opportunities. These circumstances have exacerbated the problem and the marginalized communities are striving hard to make their both ends meet. In this backdrop, RAHMA Islamic Relief Pakistan (RIRP) with the help of Charity for Life, Denmark decided to provide Olive plants for grafting to the most marginalized people to support livelihood opportunities through income generation among these communities. Overall, 1200 plants were provided to these identified families (mostly widows) in different areas of District Kotli, AJK such as Kohafi, Banar, Kotli, Tata Pani, Gulpur, Sehnsa and Brund.





MISCELLANEOUS VISITS, MEETINGS, TRAININGS

- On April 17, 2021 Syed Hussnain Ashar, President Pakistan Community Norway and other respected guests visited RAHMA Head office and RAHMA Model School. They admired the efforts of RAHMA Team and wished best for the future.

STORIES FROM THE FIELD

1) FROM RAHMA MODEL SCHOOL, JANPUR, RAHIMYAR KHAN

a) Sidra Fazal is a student of RAHMA model school GML RYK campus. She is in 2nd standard and she also belongs to a poor family. Her father is a farmer. She's the only one in her family who is studying in school.

RAHMA Model School is situated in an area where the literacy level was below one percent. People from different backgrounds and families started taking interest but their basic educational knowledge was very low. Sidra is a girl belonging to a family which was totally unaware of education. When she got admission in RAHMA Model School she was unable understand the basic concepts of her course.

She used to sit confused and nervous in the class. Her class teacher and principal started analyzing her which helped her to speak out about her problems to us. We all started counselling her by arranging meetings with her individually as well as with her parents.

By observing and analyzing various aspects of her personality finally teachers got her weakness. As she was from a backward area so the main reason of her poor performance was the burden of daily work. Her lesson was decreased and by the end of 1st term, she was only able to recognize words and the pattern. With the passage of time, with the help of her teacher, she started improving further and by the end of 2nd term, there was a clear difference between her past progress and recent one.

Now, after doing parent teacher meeting with regular intervals of time, both school staff and parents are taking great care of her interest and calibre which can be seen clearly in her performances. She is doing better now in both curricular and extracurricular activities. Also she is a good player of badminton.

She said, "RAHMA model school environment has changed me and my study routine as well. After getting admission I wasn't aware of anything regarding study stuff. In my pre schooling I was being taught by this way so I didn't know that is there a problem for me or not. I wasn't helped from my teachers. They taught us like this."

Sidra's parents said that, "we are thankful to RAHMA and their staff that they put their efforts to solve this issue. We weren't told by her any other school teacher. After PTM we realized that education is more important and super power for our children. We are very thankful to RAHMA Model School Staff and RAHMA Islamic Relief for taking care of our children. May Allah bless RAHMA and their donors"

2) WATER PROJECTS, RAHIMYAR KHAN

Faiz Din is a young man and by profession he is a laborer on daily wages. He is very hard working person and he is only person earning for his family, his income average is 16000 rupees per month and he is managing his house expenses very hardly. Faiz Din said that about one year earlier he suffered continuously from the diseases of stomach & diarrhea, he very often had complained stomach problem and he visited many times to different Hospitals and spent a lot of money on treatment. The doctor advised him to avoid the consumption of underground water because the water of his area is much polluted and rate of Arsenic and TDS in that area is very high, so they must use the filtered water. He belongs to a very poor family and he hardly managed the House expenses to run his family expenditure, and was unable to afford the filtered water for himself and his family as its cost is very high.

Faiz Din said that once his friend told him about a water filtration plant which was installed in other UC and told him that he get water for his family from that UC, but the area was very far approximately 12 kilometer, he said that he was forced to travel due to his family condition since 2019, he was travelling on daily basis to get water from that UC.

Faiz Din said when he changed the water he observed that his health started to improve day by day. He also told his neighbors about this and they requested by him start to use this safe water. He said that several times, he and other locals from his community visited to different local stakeholders like MPA's, Chairman of Union Council, and different NGO's and requested them for water filtration plant but no efforts were made by them.

He said one day when he heard from his neighbor that RAHMA Islamic Relief team visited their area and collected water samples to analyze the water quality and installed a water filtration plant at Shahid Abad for the welfare of our area, at that time he was very excited that his difficulty regarding getting filtered water from far area is near to end and soon they will get filtered water from their hometown and his all family members paid thanks to Allah and pray for those who were donating this filtration plant for our area. After some days RAHMA team installed a RO water filtration plant in his area. On the day of opening ceremony, he distributed sweets among people.

Faiz Din said approximately 3000 people are drinking safe and healthy water on daily basis and he is very hopeful that they are safe from Stomach & other related diseases. He said, "I have no words to say something for those who have contributed in this cause and helped people like us who do not have any other hope in their lives."

3) FROM RAHMA HOSPITAL KHUIRATTA, Azad Jammu & Kashmir

Diabetic Foot

People with diabetes are prone to develop foot problems due to prolonged period of high blood glucose level, showing signs and symptoms of change of skin color, temperature, swelling of feet or ankles and pain in legs, resulting in damage of blood vessels and nerves in the feet or legs. Diabetic Foot affects nearly 6% of patients as infections, ulcerations and destruction of tissues of foot. The patients came in RAHMA Hospital Khuiratta from different villages of the tehsil and adjacent tehsils.

Muhammad Maroof aged 43 years R/o Andarla Kotera (Kund) of tehsil Khuiratta was referred by Dr. Abdul Rauf Nishtar (his cousin) for expert treatment of Diabetic Right Foot. The patient was completely recovered within two month with high quality dressing on daily then alternately basis under the umbrella of anti-biotics, anti-diabetics

and anti-inflammatory drugs ensuring good glycemc control with quality anti-septic dressings.

Hypertension & Paralysis/Paresis

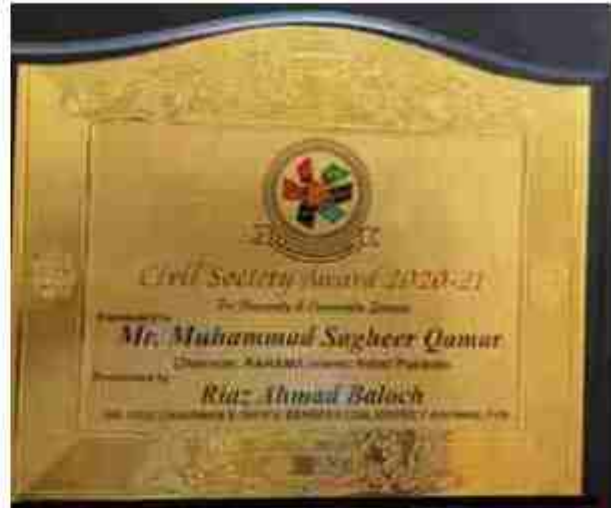

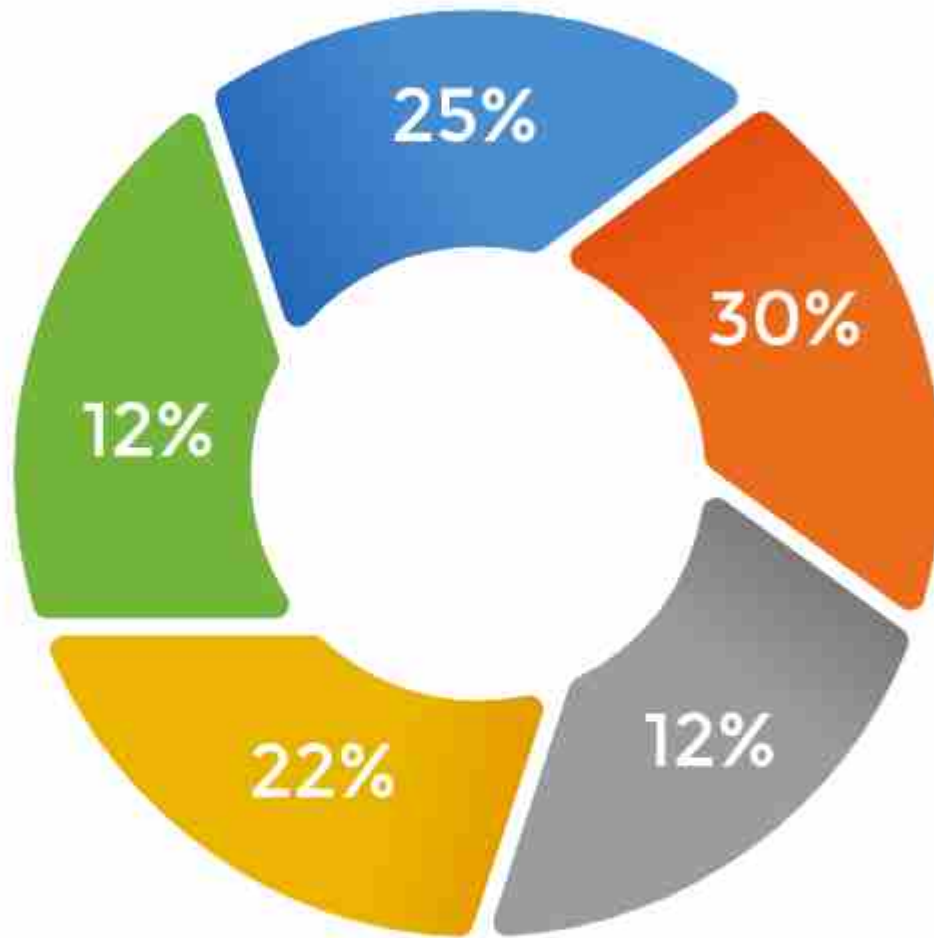
